



## Leios Seed Round Token Sale

Leios International, Inc. has begun its sale of the LEIOS tokens, a staking token necessary for our remittance and payroll platforms. This stage of the sale sees the highest bonus for the LEIOS token, at 100%. This high bonus rate is only available for the first 4% of the sale and will not be offered again after raising the seed round target of \$251,250. The minimum purchase amount for the seed round is \$1000 of LEIOS tokens.

Current payment options are in ETH or BTC, but will be considered as payment in USD based on CMC conversion rates at the time of payment. The tokens will have locks as listed below, for reasons based in best legal and distribution practices.
